"Obviously we were one point better and about five-tenths of a second better, and that's about it. That's all it takes to advance and we're pleased about that. We played a team tonight that would not quit. We had a chance, we felt, to take control of the game on several occasions when the lead got to double figures, and each time we went into a bit of a drought. I thought we had some really great looks at the basket. I thought we had better looks than they did, to be honest. We were just like, naked open, and the ball would not go down. If there's something wrong with out team I'd want it to be that because I think that's something we will do well. We will shoot the basketball well. Every time we went into one of those mini-droughts, they picked it up. They hit threes—Jackson hit them, Collins hit them, Greer, Brower. It was one of those nights when we just couldn't pull away from them. But again, it only takes one point to advance and we're very pleased with that. I thought we played much better than we did last week in Tallahassee and had been playing over the last two-three weeks. That's a good sign for us. All you want to do in any game in the tournament is just win and advance. I have a lot of respect for our team. After a hard week of practice they came out and played well. I thought Tony led us and gave us some semblance of the organization on offense that we've been lacking. I like the way he attacked. Obviously Tim had a great night inside and took on their whole inside attack. We finally hit some free throws down the stretch. Not as many as we would like, but we did hit some, enough to win the basketball game.

[Defense on Kerry Thompson] "I thought in Tallahassee he had free run on the high-post pick. We did on occasion try to double him, probably not as much as we would have liked. We thought one of the keys to our defense would be our ability to control him and keep him out of the lane. I switched defensive assignments going into this game. Jerry Braswell guarded him in the last game, but I wanted to challenge Tony and I thought he did an excellent job guarding Thompson, who I think has developed into one of the top point guards in the ACC."

Pat Kennedy, Florida State

'First I want to take the opportunity to address the NCAA issue. I found it interesting when I looked at Steve Wieberg's [USA Today] team and thought about Florida State and our 16 wins and our four wins over top-10 teams. I looked at some of the conferences with six teams in the tournament and only one or two of the teams are ranked. I hope the committee does a strong job and that they will look at our conference.

"One of our fears heading into this game was Timmy Duncan having a great game. Our guys have worked so hard on him all year. We tried to be physical with him, but tonight he would not be denied.

"We had a lot of great looks in the first half. But as our lead guard has gone, we have gone, and they did a good job on Kerry [Collins] tonight. We will take a day or two to get over the pain of it all and then see what happens.

"Luchman has done a pretty good job on Duncan over the years. If you're not extra physical with him, you won't wear him down. He was strong from tap to finish tonight.

"We did a nice job on their perimeter and didn't get double figures from their other post position, so it was just Timmy.

"Shot making was our biggest problem. If we had knocked down a few more shots in the first half, we would have been in better shape."
