Tallahassee, FL - The Florida State Women's soccer team (7-3) recorded their fifth shut out of the season in heavy rain, blanking the Furman Lady Paladins (4-4) 4-0 at the Seminole Intramural Soccer Complex.



Freshman forward Kasey McCall returned to the scorer's column as she ripped an unassisted shot from 25 yards out right before the first half ended. She leads the team in goals, assists and offensive scoring points.

Sophomore defender Janna Walkup tallied the Tribe's final goal of the match at the 70-minute mark from a cross pass by freshman forward Erin Grimsley.


The Seminoles return to action on Tuesday, October 1st against the Tennessee Lady Volunteers at the SISC, 7 p.m.


